CLIMATE ACTION INCENTIVE PAYMENT (CAIP)

For the last two years, Ontario residents (and some other provinces) have received a refundable credit for the Climate Action Incentive (CAI) as part of their tax return. This amount was used to increase their refund or decrease their taxes payable.

This year, the CAIP will be paid separately from your annual tax filing and paid directly to each family or individual over 18 on a quarterly basis starting in July 2022. The application is part of your annual tax return. The credit is not limited by income. If you receive an unexpected payment in July 2022 and quarterly afterward, this may be the CAIP. Registering for Direct Deposit through your CRA My Account is recommended.
