- Contact information
- Relationship/role of individual(s) to organization
- Involvement with the incident
- Incident details (who, what, when, where, etc.)
- Program actions to date
- Current status of the situation

- Contact information
- Immediate recommendations to ensure: the safety of all parties, external reporting, internal reporting
- Mid-term recommendations to course correct
- Long-term recommendations to support a culture of safety
