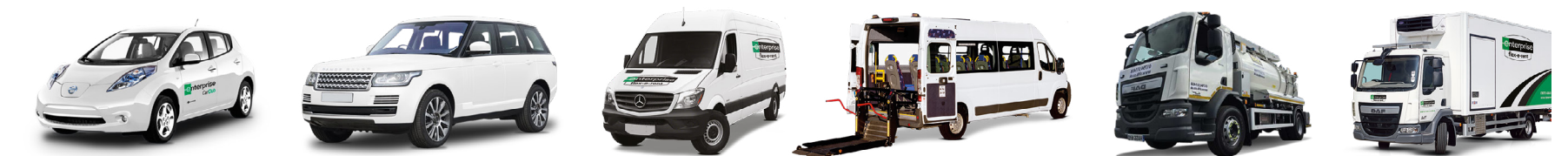

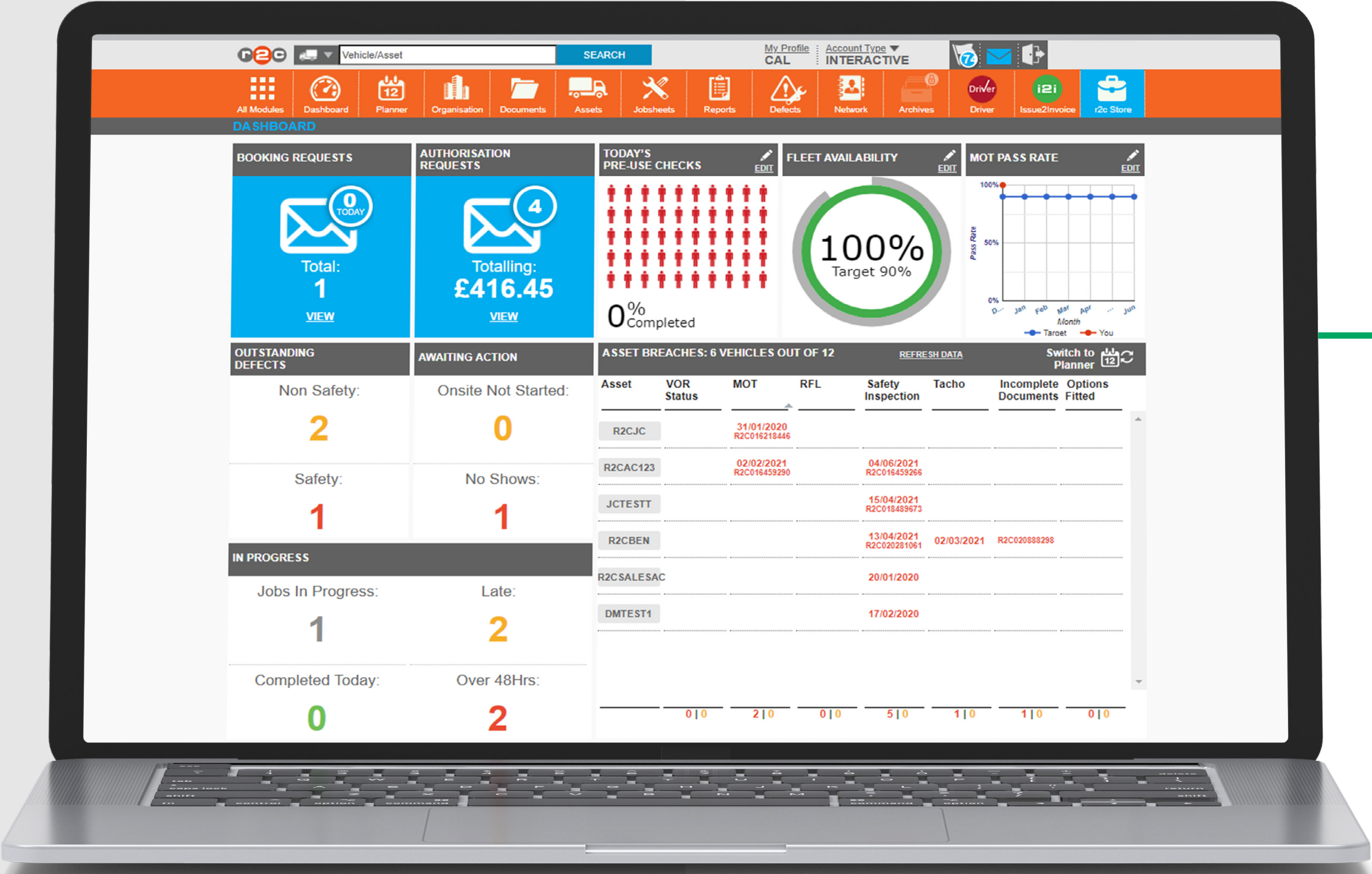

The new Enterprise compliance platform is available free of charge to all customers and covers every vehicle we supply. As soon as you are registered and set up on the system, you will be able to:

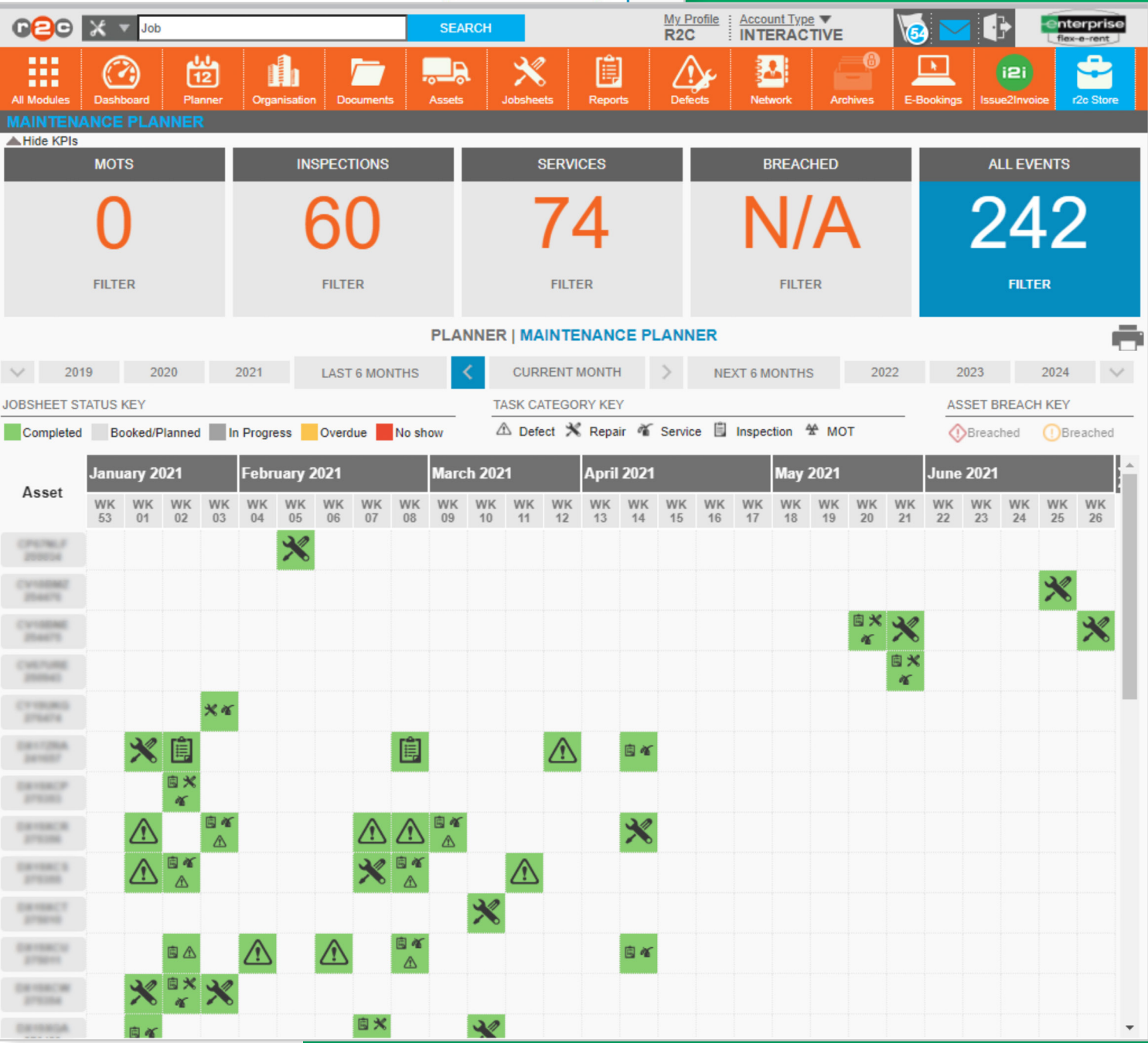
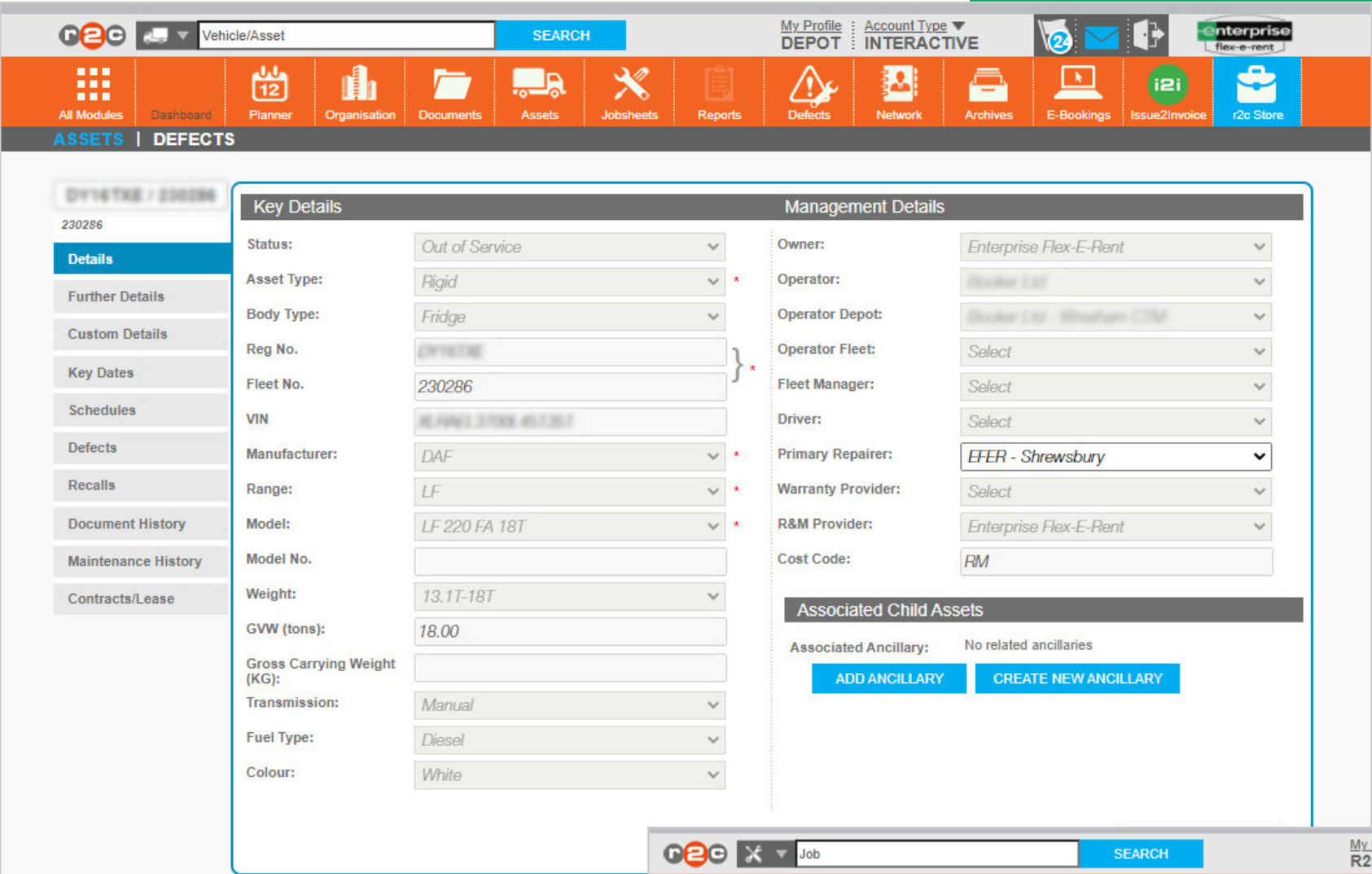


- Access a full schedule of events for your Enterprise fleet

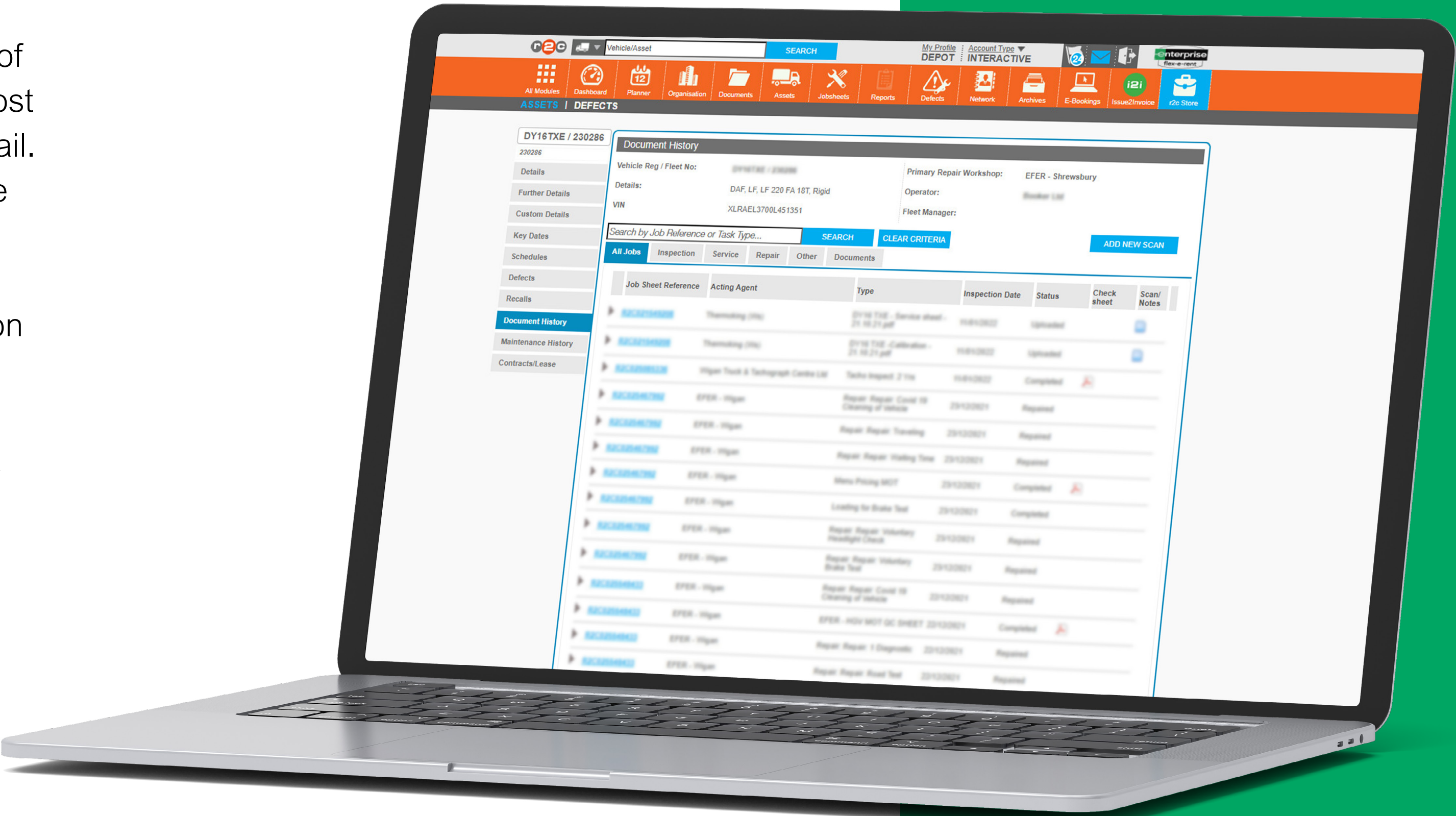
