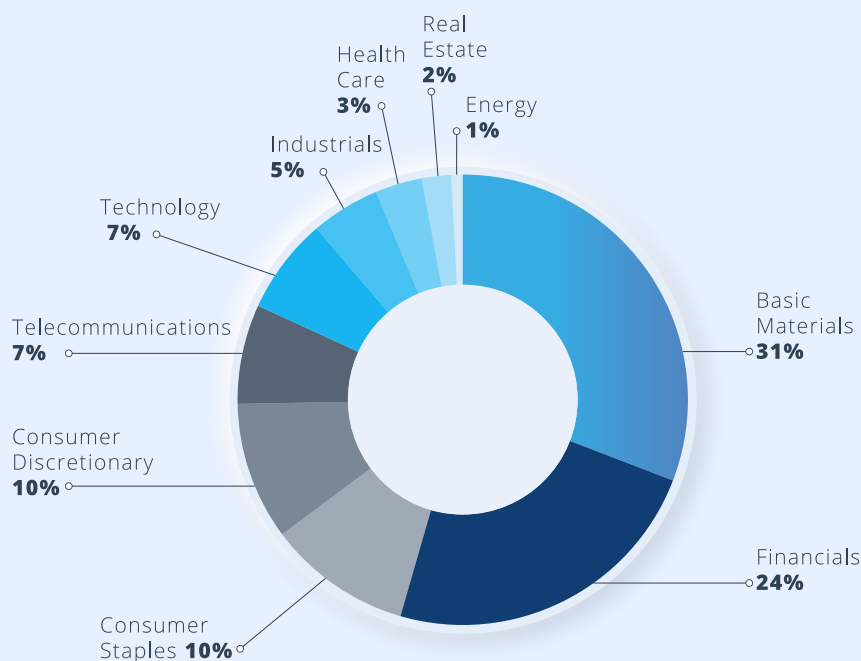
## FUND OBJECTIVE AND STRATEGY

The 10X Top 60 SA Equity Index Fund is designed to offer long-term capital growth provided by equities whilst limiting the concentration in any single share. The Fund seeks to track as closely as possible the performance of the 10X Top 60 SA Equity Index.

## ABOUT THE 10X TOP 60 SA EQUITY INDEX

The 10X Top 60 SA Equity Index consists of the 60 largest shares on South African markets, with a 6% cap applied at the semi-annual rebalance, to limit concentration risk in any single share.

The Index is independently calculated by S&P Dow Jones Indices, one of the largest and most respected index calculation agents in the world.

## RISK PROFILE

The fund has a high risk profile as it has a 100% allocation to equities. Prices of stocks can rise and fall sharply over short time horizons, but equities as an asset class have historically delivered the highest returns.

Risk is managed by diversifying investments across 60 shares. Concentration risk is further reduced by capping the exposure to any single share at a 6% weighting.

The suggested minimum investment term is seven years or longer.
