Recap of 2021 MLS Rules and Regulations Updates

Your MLS Committee works to keep *GKAR MLS Rules and Regulations* up-to-date according to NAR requirements and local agent needs. Here is a quick recap of the new or updated *Rules and Regulations* that were made in 2021. Click below to view the new or altered language as was submitted to the Board of Directors.

- Implemented Section 1.2.23 Virtual Staging and Section 1.2.24 Virtual Alteration
- Updated Section 1 Listing Procedures to further define type of listings permitted in the MLS system
- Updated Section 21.1 Lockbox Equipment through Section 21.15 Supra Key Borrowing to remove language referring to the discontinued SentriCard. Language related to the SentriLock smartphone app, SentriKey, was added
- Updated Section 1.2.4 New Residential Construction Listings, Section 1.2.10 Marketing Remarks, and Section 1.2.22 Redundant Listings to relabel "Marketing Remarks" to "Public Remarks" to align with the language change in flexMLS

ZipForms Renewal Information

GKAR will continue to offer zipForms as a Member benefit in 2022. As a Member benefit you will not pay additionally for the e-Form service, but it will be included in your monthly fees you already pay.

Just as you have done in previous years, you will need to renew your zipForm account. This typically takes place around February of every year.

When renewing, you will add the MichRIC® bundle to your cart for \$0.00, and then checkout. The MichRIC® bundle will include the zipForm Agent Edition Transaction Management System, zipForm Mobile, zipLogix Digital Ink, LionDesk CRM and zipForm MLS Connect.
