Investment Strategy: The Fund provides an exposure to New Zealand Government and Corporate bonds. Kōura invests directly into fixed income securities in New Zealand and aims to replicate the Bloomberg New Zealand Aggregate Index. A fixed interest allocation in a portfolio is important to preserve capital albeit at the expense of returns.

Monthly Commentary:

The koura Fixed Income Fund return was 0.4% in November, the first positive return for a few months. During this month, long term interest rates have not risen as we have seen in previous months, and the difference between short and long term interest rates has flattened.

The two key metrics that markets are looking at currently around interest rates are Jobs and Inflation data – both of which are the key inputs used by the US Federal Reserve as to what happens with the Fed Funds rate (the US equivalent of New Zealand's Official Cash Rate). As both of these continue to show strength in the economy, the rhetoric has changed from Inflation being transitory to more permanent, leading to expectation that the Fed Funds rate will starting to rise in mid - 2022.. The New Zealand bond market takes direction from the US so this is something to watch.

New Zealand's Central Bank was one of the first in the world to start lifting interest rates, with the Official Cash Rate increasing in October followed by a second increase in November and further increases expected over the next 12–18 months.
