What is the purpose of this update?

This document tells you how the koura KiwiSaver Scheme US Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. koura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund provides investors an exposure to the US share market. The Fund invests in underlying funds to provide this exposure. The Fund expects to deliver a negative return once in every 4-5 years.

What are the risks of investing?

Risk indicator for the US Equities Fund¹:



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lily received a return after fund charges were deducted of \$2,518 (That is 25.18% of her initial \$10,000). Lily also paid \$30.00 in other charges. This gives Lily a total return after tax of \$2,488 for the period.

The funds exposure to assets denominated in foreign currencies was 100%, of which 70.7% was hedged. This means the fund's unhedged foreign currency exposure was 29.3% of the net asset value of the fund.

Notes

- 1. As the fund started on 23 October 2019, actual returns for the fund are not available until then. To calculate the risk indicator for the five-year period ending 30 September 2021, market index returns have been used up to 31 October 2019 with actual fund returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
- 2. Performance has been calculated from 23 October 2019, when the first investment was made in the fund.
- 3. The bar chart show fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted.
