What is the purpose of this update?

Description of this fund

This Fund provides exposure to emerging markets including Eastern Europe, the Middle East, South America, Africa and Asia including China. The Fund will invest underlying funds to provide this desired exposure. The Fund expects to deliver a negative return once in every 3-4 years

What are the risks of investing?

Risk indicator for the EM Equities Fund¹:



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of year, Lily received a return after fund charges were deducted of **\$3,084** (That is 30.84% of her initial \$10,000). Lily also paid \$30 in other charges. This gives Lily a total profit after tax of \$**3,054** for the period.

Notes

- 1. As the fund started on 23 October 2019, actual returns for the fund are not available until then.
