Honors Scholarship for Undergraduate Programs

Nexus University is proud to offer Honors Scholarships. These scholarships may apply to active students starting an undergraduate program at the School of Health Science and Nursing or the School of Business at the commencement of academic year 2020-2021. These scholarships are in keeping with our mission to form professionals through educational experiences that stimulate ethical behavior, as well as an attitude of enterprise, innovation, leadership, and respect for cultural and social diversity.

ELIGIBILITY

- Honors Scholarship may apply to active students only coursing an undergraduate program at Nexus University.
- The honors scholarship is non-transferrable to any other program or person.
- The honors scholarship may be combinable with a Nexus University career scholarship awarded on the same academic year.
- Honors scholarships may be applied only to active students that meets the Dean's List criteria by achieving a 3.50 to 3.79 GPA.
- Honors scholarships may be applied to active students that meets the Executive Director's List criteria by achieving a 3.80 to 4.00 GPA.
- Honors Scholarship will be disbursed by semester.
- Honors scholarships only applies to undergraduate programs core courses.

SELECTION PROCESS

- Scholarship selection shall not be made with regard to race, color, religion, sex, sexual orientation, gender identity, age, national origin, disability, veteran status, or any other category protected by federal, state, or local law.
- The recipients of this Honors Scholarship will be selected by the Nexus University Scholarship Committee consisting of representatives from Nexus University. Non-faculty members may assist in the selection committee process.
- The Honors Scholarship award will be based only on GPA requirements.
- The decision of the scholarship selection committee is final and not subject to a review process.
- Nexus University and its employees, officers, directors, affiliates, agents, and representatives are not responsible for any typographical or other errors in the offer or administration of the [scholarship/grant/award], including, but not limited to, errors in any printing or posting of these terms and conditions, the selection and announcement of any awardee, or the distribution of any Honors Scholarship. Nexus University may correct any such errors in its sole discretion.
- Any necessary determination, or clarification, as to the interpretation or to the application of a particular term shall be made by Nexus University in its sole discretion. Nexus University reserves the right in its sole discretion to terminate, suspend or make any changes or modifications to the Honors Scholarship, including, but not limited to, the criteria, the selection process, the deadline dates, and the terms and conditions.

- Any student suspected of tampering with or disrupting any aspect of the Honors Scholarship award process will be disqualified. All decisions of Nexus University are final. By participating, a student (i) agrees to be bound by these terms and conditions, (ii) agrees to release, indemnify and hold harmless Nexus University and its employees, officers, directors, affiliates, agents, and representatives, from any and all claims, liabilities, losses and damages of any kind arising in whole or in part, directly or indirectly, from his or her application or acceptance, possession, use, or misuse of the Honors Scholarship, and (iii) grants Nexus University a sole, worldwide, perpetual, royalty-free, irrevocable, sublicensable, transferable right to use his or her award, as well as his or her name, likeness, voice, biographical information, and statements, for advertising and promotional purposes, in any media now known or hereafter invented, without compensation or notification, except as prohibited by law.
- Nexus University makes no warranties of any kind, express or implied, with respect to the Honors Scholarship. Acceptance, participation in and/or use of the Honors Scholarship is at student's sole risk and Nexus University is not responsible for any damages whatsoever including special, indirect, or consequential damages arising out of or in connection with the use and/or misuse of the Honor Scholarship.
- Should Nexus University, in its sole discretion, determine that the Honors Scholarship selection process has been compromised by virus, bugs, tampering, hackers or other causes beyond its control, Nexus University reserves the right to void suspect entries and/or terminate such selection process and chose the awardees in a fair and reasonable manner.
- All disputes concerning the construction, interpretation, validity, effect and enforceability of these terms and conditions will be governed by the laws of the State of Florida without regard to conflicts of law provisions. Students agree that exclusive jurisdiction over any legal action arising out of or in connection with these terms and conditions and/or the Honors Scholarship will be in state or federal courts located in or nearest to Miami, Florida and by submitting an application, each applicant consents to such jurisdiction and venue.

AWARDS

- The Dean's List Honors Scholarships have a USD \$600 value that is awarded by semester and prorated by session.
- The Executive Director's Honors Scholarship have a \$800 value over the Dean List's Honors Scholarship and is awarded by semester and prorated by session.
- The maximum value for Honors Scholarship awarded per student in a semester is USD \$800.
- The Honors Scholarship is awarded to active students that meets the criteria to the Dean's List and Executive Director's List listed above.
- The first Honors Scholarship will be awarded on the second semester after the programs start and first semester grades are published (Session I and Session II).
- The Scholarship Committee reviews the potential eligibility of active students in a semester basis.
- If an awardee met the Honors Scholarship criteria the previous semester does not mean whatsoever that the same student will be awarded an Honors Scholarship the current or any other semester.
- The Honors Scholarship is not transferable from one academic year to the other.
- The awardee, the submission or portions thereof may be posted to the Nexus University website and used in Nexus University promotional materials.



- The Honors Scholarship has no cash value.
- Honors Scholarships that are awarded to the recipients can only be used to assist with tuition payments of an undergraduate program at Nexus University and are not redeemable in cash.
- No student will receive more than one Honors Scholarship per semester.
- The Honors Scholarship cannot be applied to any fees or courses other than the program core courses. Students are still financially responsible to cover the costs of these fees and courses throughout the program.
- Any Honors Scholarship funds that are awarded may not be used for the purchase of books, any fees that may be applicable to their degree program, and outside materials (computers, internet service, etc.).
- Any tuition paid prior to the Honors Scholarship award will be refunded to the awardee if the account reflects a credit balance at semester's end. When applicable, refund will be processed by the Bursar's office between 7 to 20 working days.
- Courses taken under the Honors Scholarship may be recorded against the student's calendar year 1098-T.

MAINTAINING ELIGIBILITY

- All existing student policies located in the Nexus University catalog must be adhered to while the recipient is a student at Nexus University.
- The student must maintain a Satisfactory Academic Standard (SAS). Please see the current catalog for SAS definition.
- Should the student falls below the scholarship GPA, the scholarship will be withdrawn.
- Should an Honors Scholarship recipient withdraw or be dismissed from Nexus University prior to disbursement of all Scholarship funds awarded to him or her, the balance of the tuition funds awarded, but not disbursed, will be terminated and will not be available to the student for future courses.
