

# LION CITY DANCE CONVENTION 2021 - DANCE BATTLE RULES & REGULATIONS

## 1. CATEGORIES

1.1. All participants shall compete in their respective age categories as follows:

Age Category	Event	
<b>25 Years and Under</b>	Breaking 1v1	Open to participants born in 1996 to 2014 (7 to 25 years old)
	Open-Styles 2v2	
<b>Open</b>	Breaking 1v1	Open to participants from 7 years and above
	Open-Styles 2v2	

1.2. Participants are **allowed to compete in BOTH age categories and event.**

1.3. Participants who turn 26 in the year 2021 are not allowed to participate for U25 Category.

## 2. REGISTRATION

2.1. Registration fees apply as follows:

Category	Registration Fee
25 & Under Breaking 1v1	\$20 Payment upon registration
Open Category Breaking 1v1	
25 & Under Open-Styles 2v2	\$40 total; \$20 per pax Payment upon registration.
Open Category Open-Styles 2v2	

2.2. For the 2v2 Battle Category, each team will have to register two participants for the competition. No changes are to be made to the team list throughout the whole competition once the payment is made.

2.3. **Registration constitutes representation; that is, once a participant is registered for a team, he or she is deemed to have represented his or her team. Hence, the participant is not allowed to represent another team in the same category.**

2.4. Organizers reserve the right to reject the registration of any participant(s) and or any team(s) at their own discretion.

2.5. A follow-up email with the allocated reporting time and details will be sent after **24th October** after the registration is closed.

2.6. **\*VACCINATED** participants will be required to produce proof of vaccination at the point of registration at the auditions and the finals. Please note that there will be no refunds if the participants do not meet the criteria.

2.7. **UNVACCINATED** participants must provide a valid Pre-Event Testing (PET) result from any MOH-approved medical service provider on the actual day of auditions and finals. Unvaccinated participants who managed to enter the top 16 finals will have to provide another PET result from any MOH-approved medical service provider.

PET must be valid for 24 hours that covers the duration of the event. E.g. If the event ends at 6pm, the test should be done nothing earlier than 6pm the previous day.

Please note that there will be no refunds if the participants do not meet the criteria.

**\*An individual is considered fully vaccinated two weeks after he or she has received two doses of Pfizer-BioNTech/Comirnaty, Moderna or any WHO EUL vaccines.**

### **3. FORMAT OF AUDITION**

The **OPEN-STYLES BATTLE** rules apply to all situations not specifically addressed below.

3.1. Each team in the 2v2 battle consists of two participants.  
1v1 battle consists of one (1) participant.

3.2. Five (5) Judges for each Battle Category.

**3.3. Both event auditions will be done in a battle format.**

3.4. Each judge will be scoring each team or solo category contestants a score out of ten (10).

3.5. Each team or solo category contestant will be given a set duration to showcase their round.

Open-styles: 2mins per round (Team Tags are allowed)

Breaking: 45sec per round

*\* Changes to round times will be at the Organizer's discretion in the event of technical difficulty.*

3.6. One (1) round for Open-Style 2v2 Battle.  
Two (2) rounds for Breaking 1v1 Battle.

3.7. Sixteen (16) Highest Scored **team/solo category contest** to qualify for TOP 16.

#### **4. FORMAT OF TOP 16 to FINALS**

4.1. Each team in the 2v2 battle consists of two (2) participants. 1v1 battle consists of one (1) participant.

4.2. Five (5) Judges for each Battle Category.

4.3. The Battles will be conducted in a Knock-out Format: The winner of the dance battle will be determined by the Judges' Vote. Individuals or teams with the most votes will qualify for the next round.

4.4. The number of rounds and duration for Open-Styles 2v2 as follows:

Top 16 - 1min per round; 1 round per dancer.

Top 8 - 1min per round; 1 round per dancer.

Top 4 - 1min per round; 2 rounds per dancer.

Finals - 1 min per round; 3 rounds per dancer

\*Team Tags are allowed

4.5. The number of rounds and duration for Breaking 1v1 as follows:

Top 16 - 1min per round; 2 rounds per dancer.

Top 8 - 1min per round; 2 rounds per dancer.

Top 4 - 1min per round; 2 rounds per dancer.

Finals - 1 min per round; 3 rounds per dancer.

*\*The number of rounds will be at the Organizer's discretion in the event of technical difficulty.*

#### **5. POSTPONEMENT**

5.1. The Organisers is at its discretion to decide to postpone the event if it thinks that the venue is unfit for competition or for any other valid reasons for which it deems a postponement is in order. Teams must abide by the decision of the Organisers.

#### **6. WITHDRAWAL AND WALK-OVER**

6.1. Any withdrawal or walk-over is considered contrary to the spirit of the dance battle.

6.2. Teams participating in the dance battle should not withdraw or give a walk-over.

6.3. For each withdrawal, it is non-refundable.

#### **7. PRIZES**

7.1. Cash Prize will be awarded to the top three (3) teams of each category.

## **8. DISPUTE MEDIATION**

8.1. The judges' decision are final.

8.2. Competitors are not allowed to interfere with the final decision taken by the judges on points of laws/rules after clarification has been sought. If such interference results in the disruption of any battle, the case will be referred to the Organisers for appropriate action.

8.3. The Organisers will have the final decision in all dispute matters.

## **9. DISQUALIFICATION**

9.1. Participating teams and individual will be disqualified if found committed to any of the following:

- i. -Participants who turn 26 in the year 2021 are not allowed to participate for U25 Category.

10.2 All results involving the team which has been disqualified will be considered null and void.

## **10. FIXTURES**

10.1. No change is allowed once the fixture has been arranged.

## **11. AMENDMENTS**

11.1. The Organisers shall have the right to delete, add or amend the rules and regulations laid down herein.

11.2. The Organisers reserve the right to interpret or amend the rules and regulations of the competition at any time.

## **12. HEALTH AND SAFETY**

12.1. Participants are not allowed to share

- i Water from the same container
- ii Towels

12.2. Facemask must be put on at all other times other than during the period of physical activity.

12.3. Participants who are feeling unwell will not be allowed to attend the event.

12.4. Participants must adhere to prevailing Safety Management Measures at all times.
