UCDAVIS Transfer Opportunity **Program**

In closing, here is a bit of news that we can use. Transfer Counselor Angela Khoo and Dean of Counseling and Equity Lisa Webb recently secured an agreement with UC Davis that allows Merritt College to become part of their Transfer Opportunity Program (TOP). TOP is a transfer preparation program designed to support partner colleges in their efforts to increase the number of

transfer-ready students (particularly first generation, low income, and underrepresented students). This partnership will make the following opportunities available to Merritt Students:

Merritt College puts students first. Through our rich educational programs, we foster a culture of equity and inclusion that empowers students to achieve their greatest potential and make meaningful contributions to their respective communities and our global society.

- 1. Regularly scheduled individual online transfer advising sessions with a TOP Advisor (which includes discussing the UC application process, university admission process, major requirements, and student housing).
- 2. Group peer opportunities for students interested in similar majors
- 3. Access to TOP annual events
 - Discover UC Davis (March 4, 2022): a transfer empowerment conference showcasing the many opportunities available to transfer students at UC Davis
 - Aggie Transfer Scholars Week: a week-long program for prospective students focused on transfer and career planning

As great as this opportunity is, I am thrilled to report that as a result of a grant we received through the *Student Academic Preparation and Educational Partnerships* (SAPEP) Program, the fee that community colleges typically pay once they are designated as a TOP institution school has been waived for the next three years.
